RESULTS OF ANNUAL GENERAL MEETING

SHAREHOLDERS APPROVE 11.3% PLACEMENT TO DIRECTORS

I am delighted to announce that at the Annual General Meeting held yesterday in Brisbane, all resolutions were passed unanimously on a show of hand and carried overwhelmingly by proxy votes received from Shareholders.

The passing of resolutions 4 to 12 means that the Directors will subscribe for 6,300,000 shares delivering proceeds of \$315,000. As a result of this placement, Orion will then have 55,696,686 shares on issue and the Directors will now collectively have 12.45% (6,934,250) of the issued shares.

This placement to the Directors is on exactly the same terms and conditions that were offered to all shareholders in the recent rights issue and is a clear demonstration of the confidence that your Board has in the Company and its projects.
